Advice:

If:

- *the lack of information about the requester prevents responding to the request for information, the controller shall notify the requester to complete the request or provide sufficient proof of his/her identity; the controller shall postpone the request if the requester does not provide the respective data within 7 days from receiving such notification;*
- *the request is incomprehensible, unclear vis-à-vis what information is required by the requester, or phrased too generally, the controller shall notify the requester to specify the request; the controller shall refuse the request and if the requester does not provide the controller with respective data within 7 days from receiving the notification.*

The controller provides the aforesaid information free of charge. If the requests made by a data subject are clearly unfounded or excessive, in particular because of their repetitive character, the controller may (a) charge a reasonable fee based on the administrative costs of providing the requested information or communication or taking the requested action; or (b) refuse to fulfil the request.
